## A Message from the Executive Director

Nov. 18, 2020

Dear Residential Living Residents,

On behalf of the leadership team here at Asbury Methodist Village, I am grateful for your extraordinary efforts to keep our wonderful community as safe as possible during this pandemic. The next few months may be challenging, but just imagine how wonderful it will feel when we emerge from this season having kept ourselves, our community, and our neighbors safe by our actions. The fun and festivities we will have when we're on the other side! Now, as much as ever, we must not waver in our commitment to following the precautions and safety measures in place that help us minimize the spread of COVID-19.

As you may be aware, Maryland Gov. Larry Hogan announced new actions late last week to help combat the coronavirus. The positivity rate has risen steadily in recent days and weeks, and the key metrics the state tracks have worsened considerably. There's a quote we've shared before, and it's especially appropriate to share again: "*Each and every one of us has an obligation to exercise personal **responsibility** for ourselves, for our families, for our coworkers and for our neighbors.*"

**In light of the challenges still in front of us in dealing with the pandemic, and in line with Gov. Hogan's orders, I once again urge you to take the obligation of responsibility for one another seriously.**

Among the new actions laid out by the state is an important one regarding travel. With the holidays approaching, this is a critical one for us to follow. As Gov. Hogan says, with confirmed increases in positive COVID-19 cases connected to travel outside of the state, the Maryland Department of Health has expanded its public health advisory for out-of-state travel. **Marylanders “are strongly advised” against traveling to any state with positivity rates that meet a certain threshold. Currently, that threshold** – a positivity rate above 10 percent or average case rates above 20 per 100,000 over the past week – applies to 38 states. Yes, that's not a typo -- 38. **What this means for residents:**

For us here at Asbury Methodist Village, we are prepared to follow this new directive. **For Residential Living, the screening process remains in effect and is as important now as ever. Residential Living residents must complete [this online form](#) and perform temperature checks as it relates to our current screening process.** If a resident travels to one of these states identified by the CDC, the resident should inform Stephanie Sabine (301-216-4337 or [SSabine@Asbury.org](mailto:SSabine@Asbury.org)), and follow the guidelines to get tested upon return and, no matter the result of the test, additionally to self-quarantine for 14 days. If the test comes back positive, the resident should also inform Stephanie so we can determine next steps and appropriate care.

**What this means for visitors:**

Day-to-day visitors must continue to go through our screening process,

completing [the online screening form](#) and performing a temperature check upon arrival. As you will note on the screening form, if a visitor fails the screening, then they should leave the community immediately and inform the resident they were planning to see. Out-of-state visitors must get tested for COVID-19 promptly upon arrival to Maryland or 72 hours prior to travel to Maryland, per Governor Hogan. Evidence of test results is required for all out-of-state visitors, and should be provided to the screener at the time of arrival.

If a resident receives an out-of-state visitor from one of the 38 states on the advisory, the resident will be required to self-quarantine for 14 days. (Why 14 days? 14 days is the recognized minimum incubation period by the CDC for the coronavirus, and thus we follow this time period.)

I'll also use this opportunity to ask you to please continue to be honest in your responses to the screening tools and to remind you that all Asbury Methodist Village associates go through twice-daily screenings when working, screening at the beginning and end of shift, and they are additionally expected to follow all state and local departments of health guidance.

I urge you to follow the guidance from Gov. Hogan, other public health experts and our own Asbury Communities Clinical Team. Should your holiday travel plans be impacted as a result of this information, we continue to offer virtual visits – just contact Stephanie for any assistance.

The rising COVID-19 numbers are concerning. The surge is real, and the next few months could be tough. Please follow the 3 W's:

1. Wear Masks
2. Wash Hands
3. Watch Distance

Also, get outside! Please walk around our beautiful community to get some fresh air when you can. It's good for your physical and mental well-being! Be on the

lookout for your fellow residents – be neighborly and check in with folks from time to time. We like a good chat, either a physically-distanced conversation in the hallway or on the phone. It's also probably not a bad idea to keep on top of the local Montgomery County COVID-19-related metrics. You can [click here to view more](#).

The pandemic can't take away our feeling of togetherness, and we will do all we can to celebrate just that through the holiday season. We are decorating for the holidays here just as we ever have, and we're moving ahead with small physically-distanced events.
